# CALL TO ORDER

### Information: 1.01 – Call to Order

## **CHAIR'S REPORT**

### Action: 2.01 - Current Events and Announcement

Chris Nelson, director of PR/Communication, gave a brief overview of the Zoom meeting. The University followed normal protocol to ensure the integrity of the open public meeting. The meeting was recorded and Trustees and members of the President's Cabinet were given permission to unmute their microphones in order to answer/respond to questions.

Chair Burton recognized Trustee Anna Barnes, ASUU President, for her service to the University and the student body. Chair Burton read an excerpt from the resolution noting the accomplishments during her tenure. President Watkins and Lori McDonald, Vice President for Student Affairs, both commented on what a privilege it has been to work with Anna this past year and commended her on her great work. Gabe Martinez and Latifa Yaqoobi, ASUU Vice Presidents, were also recognized for their service to the University's students this past year.

# PRESIDENT'S REPORT

## Action: 3.01 – Honors and Awards to Members of the University Community, Distinguished Visitors and Research

President Watkins noted the written report included in the agenda materials and also mentioned:

• The work and mission of the University of Utah continues during these unusual times of COVID-19. In a couple of weeks, students will begin taking their finals for spring semester. Summer classes will be online.

- Andy Weyrich, VP for Research, initiated a seed grant program with the focus on COVID-19, and has received over 80 submissions. The University has a number of faculty and researchers engaged in solving this urgent societal problem.
- During this uncertain period of COVID-19, we recognize the importance of being an academic medical center and the role the University plays in the state, region and nation as a place that is leading the way on testing, patient support, data, and epidemiology. We are fully engaging with leaders in the state helping to guide them in order to keep moving forward.
- We are engaging with members of our community regularly, i.e. the Parents Association, donor, and alumni groups are meeting via Zoom as a way to inform, network, connect, and brainstorm.
- David Eccles School of Business (DESB) with support from the George S. and Dolores Doré Eccles Foundation, has had remarkable success helping business leaders think about how to manage during this difficult time. DESB has engaged participation from others within our state and is also reaching into Wyoming, Idaho, and Montana to assist small businesses that are struggling during these difficult times.
- The University is thoughtfully undertaking resource planning and implementing cost-saving measures where possible. Our efforts to plan wisely now are aimed at continued support for excellence as the University moves forward.
- CARES Act
  - 50 percent direct assistance to students
  - Funds are available to defray costs incurred and revenue lost due to COVID-19
- The University is mindful of the heroes at UHealth who are serving patients every day and putting the health and well-being of others first.

# SENIOR VICE PRESIDENT REPORT

# Report: 4.01 - Health Sciences Report

Using a PowerPoint presentation, Senior Vice President Michael Good gave an update on the COVID-19 pandemic throughout the state of Utah and nationally.

### Report: 4.02 – Academic Affairs Report

Senior Vice President Dan Reed noted the following:

#### New Leaders

- The University of Utah is expanding and reimagining programs in online and continuing education and has selected a new leader to develop the initiative. Deborah Keyek-Franssen, associate vice president for Digital Education and Engagement for the University of Colorado System, will be the university's new Associate Vice President and Dean of Continuing and Online Education.
- Nancy Songer, a Fulbright scholar and former Dean of Drexel University's School of Education, will
  join the U as Dean of the College of Education. A veteran education scholar and researcher,
  Songer taught at the University of Colorado and the University of Michigan before taking the helm
  as Dean at Drexel from 2014 to 2018. Songer served as Chair of a National Academy of Sciences'
  Engineering and Medicine Committee from 2017 to 2019 and was elected a fellow of the American
  Association of the Advancement of Science (AAAS) in 2006. Her Fulbright research into STEM
  reform has taken her to Turkmenistan and Brazil.

### Shift to Online Education

 College of Architecture+Planning's Associate Professor, Erin Carraher, is using no fewer than five digital platforms to teach her architecture studio class in the age of COVID-19—including Slack, Zoom, Canvas, Google Docs and Explain Everything.

Like all University of Utah professors and instructors, Carraher tried to replicate all the intensive hands-on analysis and interaction her course requires onto the web when the university shifted classes online March 18 to slow the spread of the virus. Faculty and students had just a few days at the end of spring break to prepare for a fundamental change in the traditional in-person lecture format of college education.

Honors and Awards to Members of the University Community

• For Utah Scholarship

Enrollment Management staff have notified 900 Pell-eligible admitted students that they will receive the For Utah Scholarship—which covers all four years of a student's tuition through a combination of university funds, Pell grants and philanthropic gifts. Many For Utah recipients are first-generation college students.

• U Swag Boxes

Admissions staff have mailed 13,000 "swag" boxes to admitted high school seniors in an effort to build a sense of community with prospective students. Watch social media for posts as these boxes arrive.

# ACADEMIC SENATE

## **ACTION AGENDA**

## Action: 8.01 - Biochemistry BA/BS

Dan Reed, Senior Vice President for Academic Affairs, introduced Dr. Vahe Bandarian, Assistant Department Head for Chemistry, who presented the proposal for a new BS/BA degree in Biochemistry.

The Department of Chemistry is proposing to establish new BS/BA degrees in Biochemistry in the Department of Chemistry at the University of Utah. This degree will incorporate core courses in chemistry, math, and physics. However, it will be distinct from the Biology emphasis in that it will provide significant flexibility to the students to fashion the degree to meet their educational objectives. This will be achieved by removing more specialized courses in the chemistry sub-disciplines in favor of courses that further explore biophysical and biochemical aspects of life processes at the molecular level, and elective offerings that provide depth and breadth.

A student who receives a Biochemistry degree will be prepared to enter the workforce in a wide variety of areas that include pharmaceutical sciences and biotechnology, or to pursue advanced degrees in the biochemical sciences, broadly defined.

## Action: 8.02 – Division of Nephrology's Dialysis Center

Mike Good, Senior Vice President for Health Sciences, presented the proposal to sell the Dialysis Centers.

In 1967, Dr. Willem Kolff established the first University dialysis unit located within University Hospital. Between 1976 and 2007, seventeen additional units were expanded throughout Utah, southeastern Idaho, and Nevada.

Early expansion was necessary to maintain a competitive advantage in the marketplace and for the program to broaden its pool of patients for research (NIH & clinical trials), education, and clinical viability. These revenue streams supported the academic missions, supplied referrals for the transplant program and other tertiary care, while decreasing unnecessary travel for patients as centers were located closer to the patient's homes.

As healthcare care cost continue to rise, chronic dialysis treatments are becoming more and more at risk for corrective or legislative actions within congress, CMS, and the broader insurance industry. Our local market has become much more competitive and the insurance landscape has changed significantly in recent years. The result is that a program that was once profitable is no longer financially viable in its present form. Many of our units are not geographically aligned within our system's hubs and outreach strategy.

We propose a 100% sale of all dialysis units, including all assets, liabilities, and future revenue streams with an effective date of July 1, 2020. Current dialysis staff will transfer to the new entity. Physicians will remain employees of the Division of Nephrology. Nephrology will continue to run non-dialysis outreach clinics, act as medical directors for local dialysis units, and serve the local communities where possible. The sale proceeds will be invested to provide a revenue stream to continue to operate the clinics and support the academic mission of the Nephrology Division.

### <u>Action: 8.03</u> – <u>RealRx Joint Venture Transfer from University of Utah Health Insurance Plans (UUHIP) to</u> <u>University of Utah Hospitals and Clinics (UUHC)</u>

Mike Good, Senior Vice President for Health Sciences, presented the proposal for the RealRx joint venture to transfer from UUHIP to UUHC.

In October 2019, the Board of Trustees approved UUHIP entering into a joint venture to create RealRx LLC for the purpose of offering a local pharmacy benefit manager (PBM). Key reasons for the JV include:

- Creates a public-private partnership Cooperative Benefits Group, LLC owns 49%, UUHIP owns 51%
- Reduces Pharmacy Prices Transparent PBM model with RealRx transferring almost all rebates to the employer, creating a competitive product in the market and generating savings for employers
- Non-U Neutral Brand Independent brand eliminating perceived conflicts of purchasing services from competing private organizations

In 2018 and 2019, UUHIP experienced significant net income resulting in substantial tax consequences for those years. Based on advice from outside tax counsel, UUHIP may qualify for tax-exempt status under Section 115 of the Internal Revenue Code (similar to the tax status available to ARUP). UUHIP would like to seek a private letter ruling from the IRS confirming that UUHIP qualifies as a Section 115 entity; however, the IRS has informed UUHIP that it would not issue a private letter ruling if UUHIP is a party to a private joint venture.

The most effective path for UUHIP to achieve tax-exempt status would be for UUHIP to transfer its ownership interest in RealRx to the UUHC. The transfer would allow UUHIP to submit an application for exemption under Section 115, compliant with IRS policies and guidelines. The IRS restrictions on joint ventures are unique to Section 115 and would not jeopardize the University of Utah's tax-exempt status under Section 501(c)(3).
